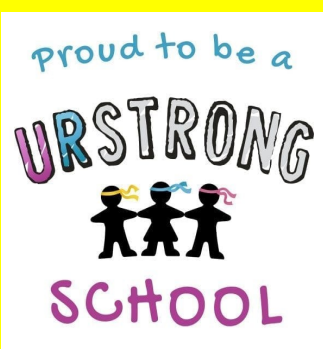

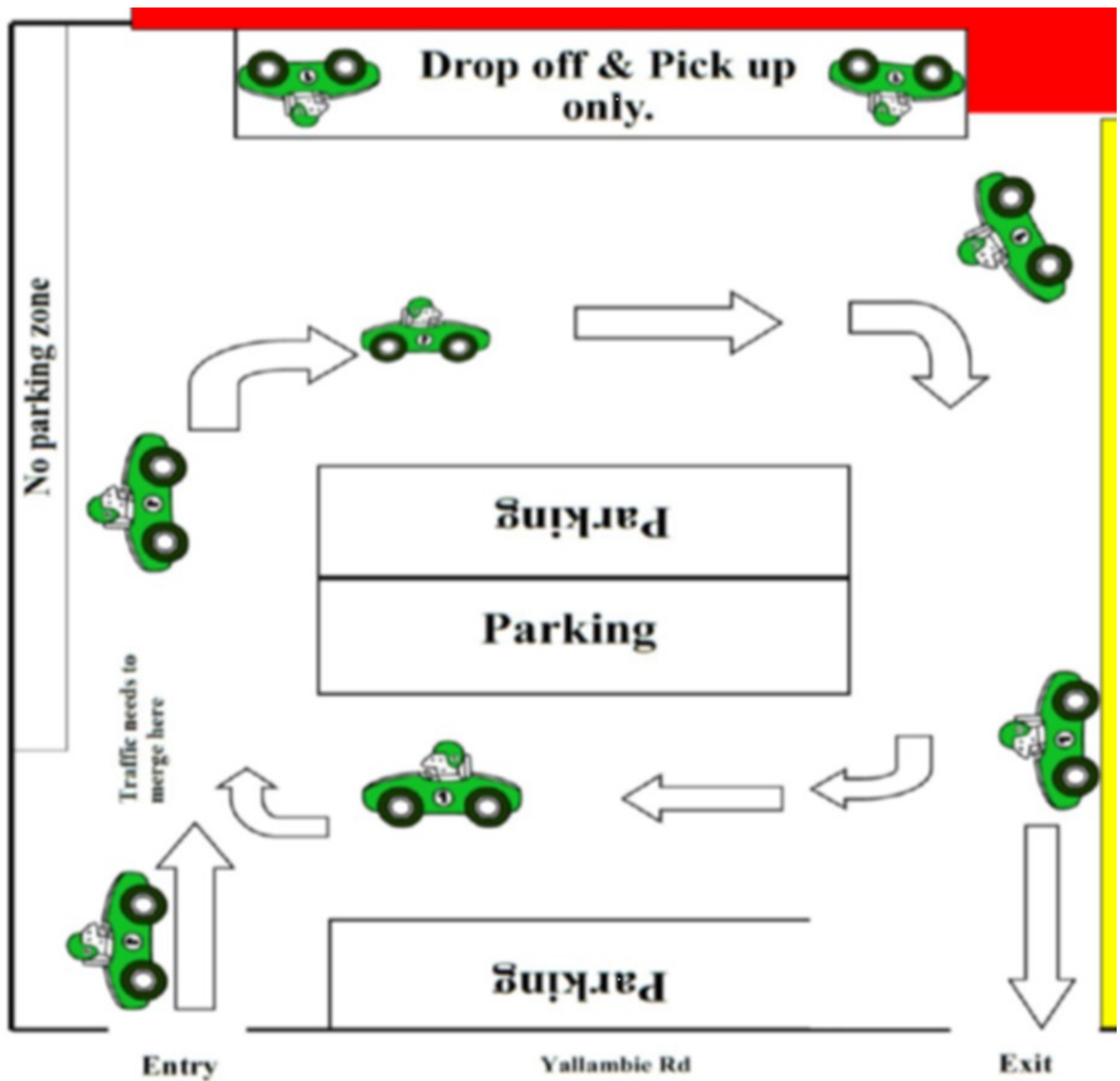

UPDATING CONTACT/EMERGENCY DETAILS

Can all families please ensure that you have up to date contact details at the office. This includes current address, phone numbers, emergency contact details etc.. Please send a note, email or contact the office on 9435 6070. Also, any students who have a medical condition must have up to date medical records at the office. Of most importance is to ensure Asthma, Diabetes, and Anaphylaxis management plans are up to date. These need to be signed off by your local doctor and are required to be updated annually.

COMPASS

Compass allows you to pay for an excursion and provide an electronic consent at the same time, and you can look on-line at any time to see if there are any outstanding excursion payments or consents requiring your attention. You can provide electronic authorisation for your child's absence via Compass or calling the school. Compass is used for families to book parent/teacher interviews and to access student reports. Please make sure that all your personal details are updated on Compass, if you do not know your Compass password, please contact the school office.

ABSENCE NOTIFICATION

If your child must miss school, please advise the school office as early as convenient or via Compass. If your child is running late for any reason, please ensure they come via the office to notify their presence as it is a Department of education and Training (DET) requirement that all rolls be marked by 9.15am. If any child is marked on the roll as unexplained, you will receive a Compass notification.

ANIMAL MANAGEMENT POLICY

To ensure the safety and wellbeing of all members of the Streeton community, animals are **not permitted** onsite without prior permission from the Principal or Team Leader.

NEW SCHOOL YEAR REMINDERS

CANTEEN

Our canteen days for 2024 are Wednesday and Friday. Our Canteen Manager is Medina Longhurst. As well as our lunch order provision, our canteen also has over the counter sales during recess and lunch eating times on both days. Lunches can also be ordered by downloading the Qkr! App.

ARE YOU BEING SUNSMART?

As in line with the School's Policy, all students are required to have the appropriate green school hat. Please refer to the SunSmart Policy.

ASTHMA

As part of our commitment to meeting our legislative requirements and the Schools Policy Advisory Guide, we require you to provide us with an updated Asthma Action Plan for your child. Asthma Action Plans should be renewed annually. Please follow the link below to the new Asthma Action Plan for Victorian Schools, which has been specifically designed for school to identify asthma signs and symptoms, and respond accordingly using the asthma medication device your child currently has at school. Once completed, please return it to us as soon as possible with the appropriate medication and another device aid i.e. spacer device. PERSONAL PROPERTY

Student Dress Code Policy

PURPOSE

The purpose of the Student Dress Code is to outline Streeton Primary School's requirements for student dress and appearance and to provide information about uniform purchase and support, dress code implementation and exemption processes.

This dress code has been developed by Streeton Primary School Council in close consultation with our school community to ensure that it respects the rights of individual students whilst reflecting the values and interests of our community.

The Student Dress Code aims to:

- foster a sense of community and belonging and encourages students to develop pride in their appearance
- support Streeton Primary School's commitment to ensuring that our students feel equal and are dressed safely and appropriately for school activities.
- reduce student competition on the basis of clothing
- enhance the profile and identity of the school and its students within the wider community.

The School Council has developed a dress code that we believe provides a range of choices for students and is cost effective for families.

SCOPE

Students are expected to comply with this Student Dress Code while traveling to and from school, during school hours and when attending school activities.

UNIFORM AND APPEARANCE

Our uniform items and appearance requirements meet human rights and anti-discrimination requirements as well as health and safety considerations.

Dress codes with gender specific requirements are not mandated at Streeton primary School and options are given to all students irrespective of their gender.

At Streeton cultural or religious headwear can be included as part of the ordinary school uniform. For an example of the inclusion of headwear in the list of uniform items, see Appendix A.

UPDATED POLICIES

The full list of Streeton Primary School's compulsory school uniform items are available at Appendix A to this policy.

General appearance

While at school, travelling to or from school or participating in school activities, Streeton Primary School students must comply with the following:

- Uniforms must be clean and in good repair
- Uniforms must be clearly marked with the owner's name
- Additional layers of clothing may be worn underneath the uniform for added warmth, provided these undergarments are completely hidden.

Jewellery and cosmetics

Students are not permitted to wear decorative jewellery to school. Stud earrings and sleepers worn in the ears, and watches, are the only acceptable jewellery.

Watches are not to be Smartwatches with built-in camera and/or video function.

Cosmetics may not be worn at school. **Cosmetics include makeup applied to the face and nail polish.**

Hair and Sun safety

Shoulder length or longer hair is to be tied back to help restrict the spread of nits and lice and for student safety.

School uniform hats must be worn outside from mid-August – end of April and on any other day prescribed by the school. School uniform hats may also be worn outside of this time period, by parent or student choice.

Hats are not to be worn inside.

Students are permitted to wear sunglasses during outdoor activities. Sunglasses should be close-fitting, wrap-around that meet the Australian Standards 1067 and cover as much of the eye area as possible.

A limited amount of second-hand uniform is available from the school administration office.

Support for families experiencing difficulty

Please contact the Principal or administration staff to discuss support that we may be able to provide to families experiencing difficulty meeting uniform costs, including information about eligibility for uniform support through State Schools' Relief. Streeton Primary School also has uniforms available to families to borrow on request.

UPDATED POLICIES

IMPLEMENTATION

Streeton Primary School will ensure that this Student Dress Code is communicated to all families and students through our website and the newsletter. We will assist students who may be experiencing difficulties complying with this policy where possible.

Students wearing non-compliant uniform items may be asked to change into a compliant item of clothing provided by the school.

If a student is out of school uniform or otherwise breaches the Student Dress Code on a recurring basis, a note will be provided to the student and parents/carers by the classroom teacher. If non-compliance with the dress code becomes a continued occurrence, the Principal will be informed and a phone call home may be required. In this event, the school will continue to work with the student and family to support compliance.

Measures taken by Streeton Primary School to address concerns about student non-compliance with the Student Dress Code will also be addressed in accordance with our Student Wellbeing and Engagement Policy.

EXEMPTIONS TO STUDENT DRESS CODE

We recognise that there may be situations where the application of this dress code may affect students unequally.

Students and their parents or carers may apply either in writing or in person to the Principal for an exemption to this Student Dress Code if:

- an aspect of this code prevents the student from complying with a requirement of their religious, ethnic or cultural beliefs or background
- the student has a particular disability or health condition that requires a departure from the dress code
- the student or their parents/carers can demonstrate particular economic hardship that prevents them from complying with the dress code.

When the Principal receives a request for an exemption, they will:

- consider the grounds for the exemption request
- explain the process to the student and/or their parents/carers
- encourage the student and/or their parents/carers to support their application with evidence.

The Principal or delegate will then try to negotiate a resolution that is acceptable to all parties. If an exemption is not allowed, then written reasons will be provided to the student and/or their parents or carers.

The Department's policy on Student Dress Codes requires the Principal or delegate to provide written reasons when not allowing an exemption. It also states that the Principal is responsible for managing and conducting the exemption process. In exceptional circumstances another staff member at the school or regional office may be appointed to consider an exemption request.

Digital Learning Policy (Internet, Social Media and Digital Devices)

PURPOSE

To ensure that all students and members of our school community understand:

- (a) our commitment to providing students with the opportunity to benefit from digital technologies to support and enhance learning and development at school (including our 1-to-1 Bring Your Own Device, referred to as BYOD, for Year 3 – 6 students and school purchased laptop and i-Pads for Foundation to Year 6)
- (b) expected student behaviour when using digital technologies including, the internet, social media, and digital devices (including laptops, tablets and digital Smartwatches) and department approved GSuite use and its applications, still photography and videoing, including learning from home for teacher, student and/or whole class video conferencing
- (c) the school's commitment to promoting safe, responsible and discerning use of digital technologies, and educating students on appropriate responses to any dangers or threats to wellbeing that they may encounter when using the internet and digital technologies
- (d) our school's policies and procedures for responding to inappropriate student behaviour on digital technologies and the internet including cyber safety and cyberbullying programs
- (e) the various Department policies on digital learning, including social media, that our school follows and implements when using digital technology
- (f) our school prioritises the safety of students whilst they are using digital technologies

SCOPE

This policy applies to all students at Streeton Primary School. It applies to any situation where students are representing the school, including incursions/excursions, camps, home learning and any other relevant school, based activity.

Staff use of technology is also governed by the following Department policies:

DEFINITIONS

For the purpose of this policy, 'digital technologies' are defined as being any networks, systems, software or hardware including electronic devices and applications which allow a user to access, receive, view, record, store, communicate, copy or send any information such as text, images, audio, or video. This includes Department-provided software and locally sourced devices, tools and systems.

POLICY

Vision for digital learning at our school

The use of digital technologies is a mandated component of the Victorian Curriculum F-10.

Streeton Primary School understands that safe and appropriate use of digital technologies including the internet, apps, laptops and tablets (iPads and Android devices) provide students with rich opportunities to support learning and development in a range of ways.

Through increased access to digital technologies, students can benefit from enhanced learning that is interactive, collaborative, personalised and engaging. Digital technologies enable our students to interact with and create high quality content, resources and tools. It also enables personalised learning tailored to students' learning needs and interests and transforms assessment, reporting and feedback, driving new forms of collaboration and communication.

Streeton Primary School believes that the use of digital technologies at school allows the development of valuable skills and knowledge and prepares students to thrive in our globalised and inter-connected world. Our school's vision is to empower students to use digital technologies safely and appropriately to reach their personal best and fully equip them to contribute positively to society as happy, healthy young adults.

Personal Devices at Streeton Primary School

Classes at Streeton Primary School are planned and delivered with the use of iPads, Android devices and laptops. Students must bring their charged device to school each day to be used during class time for different learning activities as directed by classroom teachers.

Our school operates a Bring Your Own Device (BYOD) program, which means students must bring their own purchased or leased device with them to school each day.

Students are required to have their own device that must:

- Is fully charged each morning
- be brought to school in a protective case
- have available storage
- iPad version 3 (iOS 11.0 or later)
- Android Device 8.0 Oreo or later
- have access to the apps required for purchase as outlined in the Streeton Primary School User agreement

Please note that our school does not have insurance to cover accidental damage to students' devices, and parents/carers are encouraged to consider obtaining their own insurance for their child's device.

Streeton Primary School has in place arrangements to support families who may be experiencing long or short-term hardship to access devices for schoolwork. Streeton Primary School has a limited

number of devices that can be loaned to students in certain circumstances for use on school premises. These cannot be taken home.

Safe and appropriate use of digital technologies

Digital technology, if not used appropriately, may present risks to users' safety or wellbeing. At Streeton Primary, we are committed to educating all students how to be safe, responsible and discerning in the use of digital technologies, equipping them with skills and knowledge to navigate the digital world.

At Streeton Primary School, we:

- use online sites and digital tools that support students' learning, and focus our use of digital technologies on being learning-centred
- restrict the use of digital technologies in the classroom to specific uses with targeted educational or developmental aims
- supervise and support students using digital technologies for their schoolwork
- effectively and responsively address any issues or incidents that have the potential to impact on the wellbeing of our students
- remind students about the photographing, filming and recording of other students. Students are not to share photos, film or recordings of other students. If a member of staff finds a photo, film or recording that is deemed inappropriate they will alert a member of leadership who will make contact with the parent/carer to seek approval of the removal of that photo, film or recording.
- have programs in place to educate our students to be promoting safe, responsible and discerning use of digital technologies. These programs include using the advised eSmart esmart.org.au developmental continuum resource provided from the Alanah and Madeline Foundation amf.org.au
- educate our students about digital issues such as online privacy, intellectual property and copyright, and the importance of maintaining their own privacy and security online
- actively educate and remind students of our *Student Engagement* policy that outlines our School's values and expected student behaviour, including online behaviours
- have an Acceptable Use Agreement outlining the expectations of students when using digital technology at school
- use clear protocols and procedures to protect students working in online spaces, which includes reviewing the safety and appropriateness of online tools (including video conferencing) and communities, removing offensive content at earliest opportunity
- educate our students on appropriate responses to any dangers or threats to wellbeing that they may encounter when using the internet and other digital technologies
- provide a filtered internet service to block access to inappropriate content
- refer suspected illegal online acts to the relevant law enforcement authority for investigation
- support parents and carers to understand safe and responsible use of digital technologies and the strategies that can be implemented at home through regular updates in our newsletter and annual information sheets.

Distribution of school owned devices to students and personal student use of digital technologies at school will only be permitted where students and their parents/carers have completed a signed Acceptable Use Agreement.

It is the responsibility of all students to protect their own password and not divulge it to another person. If a student or staff member knows or suspects an account has been used by another person, the account holder must notify their classroom teacher as appropriate, immediately.

UPDATED POLICIES

All messages created, sent or retrieved on the school's network are the property of the school. The school reserves the right to access and monitor all messages and files on the computer system, as necessary and appropriate. Communications including text and images may be required to be disclosed to law enforcement and other third parties without the consent of the sender.

Information on supervision arrangements for students engaging in digital learning activities is available in our Yard Duty and Supervision Policy.

Social media use

Our school follows the Department's policy on [Social Media Use to Support Learning](#) to ensure social media is used safely and appropriately in student learning and to ensure appropriate parent/carer notification occurs or, where required, consent is sought. Where the student activity is visible to the public, it requires consent. Social Media is any tool that can use instant messaging including and not limited to Instagram, Facebook, Twitter, TikTok, Snapchat, Pinterest, YouTube, ROBLOX, Fortnite, Clash of Clans, Minecraft and Pokemon Go. The social features within these platforms have interactive elements that allow creating an engaged a community of users. **Minecraft Education is approved for use in schools by the Department of Education as it offers a secure platform for teaching and learning.**

Our school uses Google Apps and SeeSaw for students to showcase their work, where parents/carers and peers can provide appropriate feedback and comments on the work undertaken in or relating to our classes. Parents/carers are welcome to contact our school Principal if they have any questions or concerns about students participating in this forum.

In accordance with the Department's policy on social media, staff will not 'friend' or 'follow' a student on a personal social media account, or accept a 'friend' request from a student using a personal social media account unless it is objectively appropriate, for example where the student is also a family member of the staff.

If a staff member of our school becomes aware that a student at the school is 'following' them on a personal social media account, Department policy requires the staff member to ask the student to 'unfollow' them, and to notify the school and/or parent or carer if the student does not do so.

Student behavioural expectations

When using digital technologies, students are expected to behave in a way that is consistent with Streeton Primary School's *Statement of Values, Student Wellbeing and Engagement* policy, and *Bullying Prevention* policy.

When a student acts in breach of the behaviour standards of our school community (including cyberbullying, using digital technologies to harass, threaten or intimidate, or viewing/posting/sharing of inappropriate or unlawful content, including inappropriate gaming), Streeton Primary School will institute a staged response, consistent with our policies and the Department's *Student Engagement and Inclusion Guidelines*.

Breaches of this policy by students can result in a number of consequences which will depend on the severity of the breach and the context of the situation. This includes:

- **contact parents/carers**
- removal of device (handed to parent/carer)
- removal of network access privileges
- removal of email privileges
- removal of internet access privileges
- removal of printing privileges

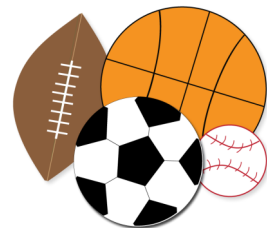

Information Sheet 2024

General Information

The School Sport Victoria (SSV) Team Vic representative program provides a development platform for Victorian students to challenge themselves against Australia's best school aged athletes across numerous sports at the annual School Sport Australia (SSA) Championships. SSV coordinate the selection process for Team Vic teams in partnership with relevant state sporting organisations.

Depending on the sport and team, the selection process involves either:

- Progressive or conference model
- State trial/s
- Results from event/s
- Based on rankings/results or talent identification program

To be eligible for selection, students must:

- be a full-time student that attends school regularly with a School Sport Victoria member school;
- have their selection endorsed by their school Principal;
- be available to attend selection trials and training sessions; and
- meet the costs of participation.

Students registering for trials are indicating that they will be available for all stages of the trial process. For information on the sports and teams participating in the SSA Championships, please refer to the individual [Team Vic sport pages](#) on the [SSV website](#).

REGISTRATIONS

All students must register to trial for Team Vic via the Game Day registration link on each [Team Vic sport page](#).

The registration dates for each sport can be found on the [Team Vic Sport and Registrations Key Dates](#) page.

Registration information for other teams will be published closer to the time of registrations opening through the [SSV website](#), social media platforms and the [SSV eNews](#).

Please note the following:

- **There is no late registration period for any sport in 2024.**
- It is the responsibility of the student/parent/carer, to check the [SSV website](#) for opening and closing dates for registrations.
- the closing dates will differ for each team.
- registration confirmation will come from GameDay and not SSV.

CONDUCT

Both [SSV](#) and [SSA](#) have Codes of Conduct to ensure a positive, enjoyable and fair trial process and Championship events. It is imperative that all participants are familiar with these expectations as well as the consequences of breaching the codes prior to participating in the trials or in Championship events.



TEAM VIC NEWS

PARTICIPATION COSTS

Participation in SSV Team Vic representative teams is fully self-funded, so students will be required to meet the costs of being a member of a team. Such costs include host state and administration levies, uniform, transport, accommodation, and meals.

SSV can provide some indicative costs to help families budget and meet the costs of participation. The cost of the SSA Championships host state and administration levies and SSV Team Vic uniform is approximately \$1000 per student.

However, the total participation cost can vary greatly, depending upon the location, travel options, timing of the SSA Championship and when travel and accommodation bookings are made. These are outside of SSV's control.

Please note, a parent/carer is required to travel with their child to the SSA Championship in 2024 and be primarily responsible for the supervision of their child outside of official SSA Championship activities.

FINANCIAL ASSISTANCE

The main fundraising approach available to families is the Australian Sports Foundation, which provides an online platform to assist with the costs of participating in the SSA Championships.

TEAM VIC SELECTION PROCESS

The trialist will be notified as to whether they have progressed to the next selection stage generally within a week of the trial(s) concluding. If it has been more than a week and you have not received notification, please [contact SSV](#).

Team Vic teams will be announced via the SSV website generally within a week of the conclusion of the Team Vic trial.
